



Water Resources Related Grant Programs

Governor's Office of Planning and Research:

Regional Resiliency Planning and Implementation Grant (ICARP)

- Priority: Plan and implement projects that advance climate resilience and respond to the greatest climate risks in their regions.
- Application Period: August 2024

U.S. Bureau of Reclamation:

WaterSmart Planning & Design Grant

- Priority: Site specific design and development of a 60% level final design package.
- Application Period: Spring 2024

WaterSmart Small Storage Program

- Priority: Water storage projects of no less than 200 acre-feet and not more than 30,000 acre-feet. Requires approved Feasibility Study.
- Application Period: Fall 2024

Water Resources Related Grant Programs

CA Department of Water Resources:

Integrated Regional Water Management (IRWM)

- Priority: Planning, implementation and disadvantaged community involvement.
- Application Period: TBD

Urban and Multi-benefit Drought Relief Grant Program

- Priority: Communities facing the loss or contamination of water supplies, addressing impacts on human health, safety, and to protect fish and wildlife resources.
- Application Period: TBD

FEMA:

Hazard Mitigation Program- National Earthquake Hazards Reduction Program (NEHRP) & Building Resilient Infrastructure and Communities (BRIC)

- Priority: Projects that reduce the risks to people and property posed by natural hazards.
- Application Period: December 2024

Regional Water Quality Control Board:

- Priority: Loan and grant funding for construction of drinking water treatment and distribution systems, water recycling facilities, remediation for underground storage tank releases, and groundwater contamination.
- Application Period: Continuous


WaterSmart - Water and Energy Efficiency Program

- Priority: Projects that result in quantifiable water savings, implement renewable energy components, and support broader sustainability benefits.
- Application Period: February 2024

CA Department of Water Resources:

Integrated Regional Water Management

- Priority: Planning, implementation, and disadvantaged community involvement
- Application Period: TBD



Watershed Related Grant Programs

CA Department of Parks and Recreation: Recreational Trails Program (RTP)

- Priority: Provides funds annually to develop non-motorized recreational trails and trails-related facilities.
- Application Period: July 2025

Cal Fire: Forest Health Program

- Priority: Funds active restoration and reforestation activities aimed at providing more resilient and sustained forests,
 ensuring future forests in California while mitigating climate change, protection from fire risk and improving water & air.
- Application Period: TBD 2024

State Coastal Conservancy

- Priority: Increase availability of beaches, parks and trails for the public, protect and restore natural lands and wildlife habitat, preserve working lands, and increase community resilience to the impacts of climate change.
- Application Period: TBD 2024

Wildlife Conservation Board

- Priority: Authorize and allocate funds for the preservation, protection and restoration of wildlife habitat.
- Application Period: Continuous

Watershed: Fisheries

CDFW: Fisheries Restoration Program

- Priority: recovery and conservation of salmon and steelhead trout
- Application Period: December 2024

CDFW: Watershed Restoration Program

- Priority: multi-benefit projects, such as projects to restore and protect rivers and streams in support of fisheries and wildlife
- Application Period: TBD 2024

CDFW: Nature Based Solutions

- Priority: Wetlands and meadows, wildlife corridors, and climate impacts
- Application Period: TBD 2024

Department of Water Resources: Riverine Stewardship Program

- Priority: Planning and implementation funds for projects that restore streams, creeks, and rivers to enhance the environment for fish, wildlife and people.
- Application Period: TBD 2024



Watershed: Fisheries

NOAA: Transformational Habitat, Restoration, and Coastal Resilience

- Priority: Projects span a broad range of habitats and restoration techniques. They will reconnect rivers to their historic
 floodplains, outplant corals to rebuild reefs, build living shorelines that will protect coasts from erosion and sea level rise,
 and more.
- Application Period: TBD

Wildlife Conservation Board

- Priority: Authorize and allocate funds for the preservation, protection and restoration of wildlife habitat.
- Application Period: Continuous

State Coastal Conservancy

- Priority: Protect working landscapes, restore fish and wildlife habitat, waterfront restoration, and coastal trails.
- Application Period: Continuous

Regional Water Quality Control Board 319

- Priority: Stream restoration and fire road improvements in priority watersheds.
- Application Period: TBD 2024

■ U.S. Bureau of Reclamation: WaterSmart-Aquatic Restoration Grant Program

- Priority: Stream restoration and fire road improvements in in priority watersheds.
- Application Period: TBD 2024

Expanded Grant Outlook

• Electric Fleet:

PG&E

- Priority: Rebates for vehicles and infrastructure with 5 year EV fleet and charging plan commitment.
- Application Period: Continuous

Internal Revenue Service: Inflation Reduction Act Elective Pay (Direct Pay)

- Priority: Elective pay provision for tax-exempt and governmental entities to receive a payment equal to the full value of tax credits for building qualifying clean energy fleets.
- Application Period: Until 2032

California Energy Commission & California Air Resources Board

- Priority: Incentives for charging infrastructure.
- Application Period: TBD

Expanded Grant Outlook

Alternative Energy / Energy Efficiency

Office of State and Community Energy Programs: Energy Efficiency and Conservation Block Grant (EECBG)

- Priority: EECBG is designed to assist states, local governments, and Tribes in implementing strategies to reduce energy use, to reduce fossil fuels, and to improve energy efficiency.
- Application Period: April 2024 or until funds are expended

State Energy Commission: Local Government Building Decarbonization Challenge

- Priority: Develop a Municipal Building Decarbonization Plan. Funding ranger is \$200,000-\$400,000.
- Application Period: May 2024

Environmental Protection Agency (EPA): Climate Pollution Reduction

- Priority: Develop and implement ambitious plans for reducing greenhouse gas emissions and other harmful air pollution.
- Application Period: TBD 2025

MCE: Commercial Energy Efficiency

- Commercial energy efficiency project financing
- Rebates: EV, Solar, Electric
- Technical Assistance

Expanded Grant Outlook

Micro Turbines

Internal Revenue Service: Inflation Reduction Act Elective Pay (Direct Pay)

- Priority: Applicable entities can use 12 of the Inflation Reduction Act's tax credits for generating clean electricity through solar, wind and battery storage projects.
- Application Period: Until 2032

Climate Adaptation

Governor's Office of Planning and Research: Regional Resiliency Planning and Implementation Grant (ICARP)

- Priority: plan and implement projects that advance climate resilience and respond to the greatest climate risks in their regions.
- Application Period: August 2024

DWR: Watershed Resiliency Program

- Priority: This program seeks to build upon the IRWM Program, placing a stronger emphasis on climate vulnerability assessment, adaptation planning, watershed-based planning, multi-sector collaboration, and equity and inclusiveness.
- Application Period: TBD 2025

Other Federal Funding

Water Resource Development Act (WRDA)

- Passage of Water Resources Development Act in 2022
 - \$28M WRDA Authorization for Marin Water
- President Biden signed the FY24 appropriations bills into law in March 2024.
 - Marin Water site visit to Nicasio Reservoir with Army Corp. staff in March 2024.
 - Army Corps of Engineers (USACE) has full-year funding that will last through Sept 30, 2024.
 - USACE has 60 days to finalize a work plan that describes how funds will be allocated at the project-by-project level.
 - The request is to include funding for MMWD's project that was authorized in the 2022 Water Resources Development Act (WRDA) so that MMWD can begin working with the Corps on the Soulajule project.

Congressional Directed Spending Request - Senator Padilla

Pine Mountain Tunnel Replacement: \$1,500,000

Summary
