I'm happy to read that MMWD is working to increase the water supply. But I am dismayed that our water board has not done anything about the archaic system of selling water by the gallon, to homeowners, religious groups, etc. etc., without any regard as to the size of the property, and the landscaping and/or vegetable gardens. We live on a lot of over an acre with gardens and landscaping on about half of it. And we are paying for water at the same rate at which our neighbors on 1/8 acre lots, with little landscaping and no gardens are. We have had a water district representative here twice, changed our controllers, installed two extra water meters, etc. to be granted a tier 4 exemption, which was then taken away. Our feeling is that the water district is a greedy monopoly, more interested increasing revenue than in bothering to take into account how homeowners, and other users landscape and garden. Isn't it time for the elected board to tell the managers of MMWD that it is time to end this one-size-fits-all method of selling water by the gallon without regard for landscaping and gardens?
