We have lived along Nicasio Creek for 39 years. We have 2 acres and the creek runs through the middle of it. MMWD has no easement onto our property. We have personally witnessed the environmental changes over these years. Here's what we have seen and experienced:

Approximately 40 years ago, before we purchased the property, the creek was dredged by MMWD. The excess gravel from the creek bed was transferred to our yard and was very evident. In 2003, we contacted MMWD because the creek bed was rising, and the flooding was getting worse. A representative came out and agreed that the creek should have been dredged every 7 years or so. However, he stated that they didn't have the money to do it. There was a lawsuit filed by our previous neighbor, Bob Ferguson, against MMWD for not doing this, resulting in the flooding of his swimming pool. Ferguson had told us there was a settlement.

The creek bed has risen dramatically, the erosion is extremely visible, and many trees have fallen as a result. There are mounds, some as high as 8 feet, lodged in the trees that need to be removed to allow proper water flow. Please see the photos we have provided.

We have brought these problems to the attention of MMWD staff in the past. Staff said they used to dredge our creek but they have not done anything to fix the issue. We feel these problems need to be addressed before even considering adding more problems by raising the Nicasio Reservoir water level.

Our concerns are:

Standing water in our backyard for 5-6 months out of the year, breeding mosquitos and algae.

Our property value and use of our property. By looking at the maps MMWD has provided, we would need a bridge to access the other side of the property.

We have even greater concern for our neighbors downstreatm. Seybolds, Shones, School, Corp Yard, Lunnys, LaFranchi (Cheese Factory), &Dolcinis.

The overwhelming impact to all of us as a historical community; some of our houses being around 150 years old.
