

Project Overview

- The project will enhance habitat in Lagunitas Creek for endangered Coho Salmon and California freshwater shrimp and threatened steelhead by:
 - Enhancing 13 sites encompassing 4,450 linear feet
 - Installing over 270 logs and 12 tons of gravel
- Phase 1 construction to begin in 2024
 - Consists of the eight upstream sites
 - Totals 2,850 linear feet
 - Includes adding approximately 156 logs and 8.3 tons of gravel





Design Approach

Add log and boulder structures to:

- Break up shallow homogenous glides
- Create deeper, slower pools for rearing
- Capture incoming gravels for spawning
- Improve insect (fish food) production









Environmental Review and Permitting

- CEQA approved August 2023 Statutory Exemption for Restoration Projects (SERP)
- NEPA compliance document currently being prepared by USBR for federal funding
- Tribal consultation is ongoing with the Federated Indians of Graton Rancheria
- Permit applications submitted December 2023:
 - Section 401 Clean Water Act Certification (Regional Water Quality Control Board)
 - Section 404 Clean Water Act Permit (US Army Corps of Engineers)
 - 1600 Lake and Streambed Alteration Agreement (California Department of Fish and Wildlife)



CEQA Statutory Exemption for Restoration Projects (SERP)





Governor Newsom signed Senate Bill (SB) 155, on September 23, 2021, adding Section 21080.56 to California Public Resources Code. This section provides a new California Environmental Quality Act (CEQA) statutory exemption until January 1, 2025, for fish and wildlife restoration projects that meet certain requirements (SERP). CDFW's Cutting the Green Tape (CGT) Program is responsible for coordinating with lead agencies seeking SERP concurrence.

- \$590K DWR Riverine Restoration Program, Sites 12-13

Phase 2 Planning Requested

• \$600K CDFW Fisheries Restoration Program, Sites 7-11

Schedule and Next Steps

- December 2023 90% Designs and Specifications
- March 2024 100% Designs and Specifications
- March 2024 Construction Schedule and Bid Manual
- February/March 2024 Board authorization to conduct competitive bid for construction and management contractor
- June*- October 2024 Phase 1 construction
